Findings:

1. Valley Creek ravine is within the preliminary subdivision boundaries. The submitted geotechnical report states that the slopes are mapped as a geologic hazard, although the conclusion states that no negative impacts should occur from development if the recommendations are followed. The creek's corridor is outside the proposed lots to be

developed, but there are potential ESA buffers on proposed lots 78-87, 26-34 and 20. Ravines are a locally unique feature regulated by Chapter 15.20 - Environmentally Sensitive Areas of the Port Angeles Municipal Code.

2. The City's cultural resources predictive model shows a low to very low probability of cultural resources on the site of proposed disturbance. Since the project is unlikely to encounter archaeological resources given its separation from soils designated with medium or high archaeological probability; the work may proceed without an on-site archaeological monitor or additional archaeological investigation.
3. The unique intersection configuration of Laurel and Alhvers and increased traffic from the development does require intersection configuration revisions to an extent beyond the traffic impact analysis recommendation to ensure vehicle and pedestrian safety.

Mitigation Measures:

1. The existing top of ravine and its buffer are required to be identified on the final plat. ESA permits are required for any development within the stream and ravine corridor.
2. Regardless of the presence of an archaeological monitor, if during ground disturbances, any phenomena of possible archaeological interest are uncovered the contractor shall immediately stop such work and provide for a site inspection and evaluation by the City Cultural Resources Officer to ensure that all possible archaeological resources are handled in accordance with applicable law. In the event archaeological artifacts, features or human remains are discovered, the City will notify the Lower Elwha Klallam Tribe and the State Department of Archaeology and Historic Preservation, as required in RCW 27.44 and 27.53. Archaeological Preservation requirements will then be enacted as applicable to State law.
3. An all way stop condition shall be implemented at Laurel and Alhvers with stop signs on all approach legs, plastic stop bars and advanced stop sign warning signs.


