WHAT: The City of Port Angeles is accepting comments on a Comprehensive Plan Amendment application proposing amendments to the Port Angeles Comprehensive Plan. A hybrid-format public hearing for Comprehensive Plan Amendment (CPA) Application No. PZ 23-26 conducted by the City’s Planning Commission has been scheduled for May 10, 2023. Verbal Comments can be made during the Planning Commission Public Hearing on May 10, 2023.

HEARING PARTICIPATION: The meeting will be a hybrid format with options for in-person and online attendance. The Audio Only and Live Hearing function will be available 30 minutes prior to the meeting. If you are unable to attend the hearing at City Hall, or unable to deliver virtual public testimony during the public hearing as described above, you may submit your written public testimony in advance of the hearing to ced@cityofpa.us prior to June 10, 2023.

DECISION AND APPEAL INFORMATION: The City Council Decision will be made based on the Staff Report and record, including Planning Commission recommendation, written public comment, and verbal testimony, no later than June 30, 2023. Any appeal of the decision shall be filed within 21 days of the final decision.
