Notice is hereby given that the City Council of the City of Port Angeles will hold Public Hearings at the regular City Council meetings on Tuesday, December 3, 2024 and Tuesday, December 17, 2024, at 6:30 p.m., or soon thereafter. These meetings will be conducted as a hybrid meetings. The purpose of the public hearing is to receive input on the proposed Municipal Code Update 24-125 to the Port Angeles Municipal Code Chapters 2.18, 16.04, 16.08, 16.09, 16.10, 16.12, 16.14, 17.13, 17.19, 17.31, 17.37, 17.44, 17.45, 17.44, 17.96, and 18.02 relating to RCW 36.70B Local Project Review Updates and Senate Bill (SB) 5290 requirements for project permit procedures.
