### 5.24.010 - Definitions.

The following definitions shall apply to the provisions of this chapter:

- A. *"Intoxicating liquor"* includes wine, beer, whiskey, and all other liquors or beverages having an alcoholic content and which are fit for beverage purposes.
- B. *"Public dance"* means any dance not held or given in a private home or residence.
- C. *"Public dancehall"* means any room, place or space, except a private residence or home, where dancing is permitted and carried on, including a room, place or space within a club.

### 5.24.020 - License—Required.

No person shall maintain or conduct any public dancehall where intoxicating liquor is sold without obtaining from the Clerk a business license for such purpose.

### 5.24.030 - License—Application requirements.

In addition to all other information required of an applicant for a business license, an applicant for a "dancehall where intoxicating liquor is sold" license shall provide the following information:

- A. The location of the dancehall where the dances are to occur;
- B. The name of the owner of the premises upon which the dances are to occur;
- C. The approximate capacity of the hall;
- D. The type of liquor to be served;
- E. Hours of operation.

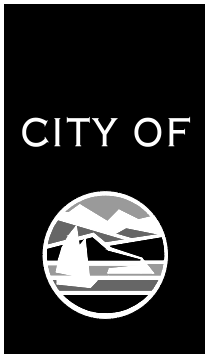
### 5.24.040 - Dancehalls—Regulations.

Each dancehall where intoxicating liquors are sold or served shall be subject to the following regulations:

Title 5 - BUSINESS LICENSES AND REGULATIONS  
CHAPTER 5.24 - DANCEHALLS WHERE INTOXICATING LIQUOR IS SOLD OR SERVED

- A. No operator of any public dancehall shall knowingly permit any person to bring, carry, or transport into the public dancehall any bottle or other container containing any intoxicating liquor.
- B. It is unlawful to sell, serve, or give away or distribute in bottles any intoxicating liquor, other than beer and wine, at a public dancehall.
- C. No operator of a public dancehall shall knowingly permit or allow any person under the age of 21 years to be present in a public dancehall, unless such person is accompanied by a parent, spouse, or legal guardian; provided, the foregoing provision shall not prohibit the entry of such person to any dining room located on the premises occupied by a hotel or motel, and actually maintained and operated as a bona fide part of such hotel or restaurant business.
- D. No operator of any public dancehall shall allow any disorderly conduct to occur on the premises, as defined by RCW 9A.84.030, as now enacted or hereafter amended.
