5.40.010 - License—Required.

No person shall operate, or cause to be operated, a hotel, motel, or public rooming house in the City without first receiving from the City Clerk a business license for such purpose.

5.40.020 - License—Application—Information required.

In addition to all other information required of an applicant for a business license, an applicant for a hotel-motel license shall provide the following information:

- A. Location of the property and building for which the license is issued;
- B. Class of construction of the building;
- C. Number of rooms;
- D. Number and kind of service rooms.

5.40.030 - Registration of guests required.

Every person conducting a hotel or motel in the City shall keep a register in which all guests shall be required to register their names and addresses. Every person keeping a hotel or motel shall indicate on the register the date of each registration, the number of the room assigned to the guest, and the number of any room to which the guest may be transferred; provided, that if two or more rooms are rented or leased to a tour group or other organization, only the person in charge of room assignments for the group or organization must be identified as required by this section. Such register shall be open to inspection at all reasonable times by an authorized peace officer. All such registration books shall be preserved for a period of at least two years.

5.40.040 - Rooms—Numbering.

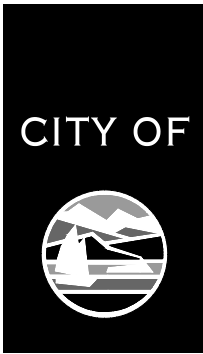
All sleeping rooms in the hotel, or motel, shall be plainly numbered on the outside of the room, with a different number being assigned to each room.

5.40.050 - Registration—False entries.

It is unlawful for any person to cause to be written in the register of any hotel or motel any other than the true name of the person registering.
