Purpose of checklist

5. How would the proposal be likely to affect land and shoreline use, including whether it would allow or encourage land or shoreline uses incompatible with existing plans?

The proposed municipal code updates are not likely to affect land and shoreline use throughout the city. Any development that is proposed once these municipal code updates are complete will still have to adhere to land use and shoreline regulations at the City, State and Federal levels.
